This exhibit shows how man and machine have combined to make Harley-Davidson Racing a king and the winner's circle its throne.



History of the Kenosha HOG Chapter Bike Blessing and its creator Dottie Young

The Kenosha Hog Chapter has not always had it's own Bike Blessing. For several years we attended Bike blessings at other locations. Dottie Young, one of our chapter members, made the suggestion that we start our own bike blessing. She not only suggested it, she followed through on it.

Who was Dottie Young? Dottie was a very special lady! She was married to Ron Young, one of Kenosha HOG chapters founding members. He led the very first ride to Baraboo. Ron was out riding one day, shortly after that first Baraboo ride, when he was killed by a drunk driver. In memory of Ron and all our fellow brothers and sisters who have passed on we continue our annual Baraboo Memorial Ride every May. Dottie knew Ron's love for the chapter and she had many friends who encouraged her to stay. She didn't ride a bike at that time, but not wanting to lose the close friendships she made she took classes and learned how to ride on her own. Dottie was 62 when she took her first ride on a motorcycle by herself. Nothing stopped her! Not her age or her battle with Breast Cancer, or even the loss of her beloved husband.

Dottie not only learned to ride, she also became a very active member of the Chapter. If anything needed to be done, she was right there volunteering. She was our chapter historian for several years. She was organized, energetic and always doing for others, both in the chapter and in other organizations. Starting the bike blessing was just one of the many contributions she made to our chapter. When Dottie got the idea for the bike blessing, she contacted Keith and they had many discussions lasting about 3 years but finally they were ready to go. Dottie contacted her minister and asked if the bike blessing could be held at her church. The church was cooperative, and why not. Dottie had served them well as church organist and in other capacities for many years. She had the place, now she had to enlist some help from the chapter. She contacted friends in the chapter to be road captains for the ride. She made sure there was a place to gather after the blessing. The first bike blessing was small with around 15-20 bikes and she could handle most of the planning by herself. As the bike blessing grew larger, she enlisted the help of Pam & Steve Rose and Ray & Paula Stumpf, as the planning committee to make sure everything went off without a hitch. Today our Bike Blessing has grown to over 1000 bikes.

Dottie was a member of the Twin Lakes American Legion Post 544 Ladies Auxiliary through which she held local, state and national posts, including National Music Chairman. She was a former member of the Kenosha chapter of the Daughters of the American Revolution; the Veterans of Foreign Wars Post 1865 Auxiliary; the Lost Chords Quartet; Sweet Adelines of Burlington, and the Western Kenosha County Historical Society. She was a remarkable lady.

In 1999, Dottie was riding to the Wisconsin State Rally when she was killed by a drunk driver. She was 70 years old. That was an overwhelming loss for all of us. She had done so much for the chapter and was an inspiration to all.

Dottie had already insured that the bike blessing was a chapter event. Pam, Steve, Ray & Paula continue today to plan that event in memory of Dottie Young and the rest of our friends who have passed on. When many of us attend the bike blessing, we do so with the bittersweet memories of a strong willed lady who inspired us all. Many thanks go out to all of you who have helped to keep Dottie's memory and dream alive.
