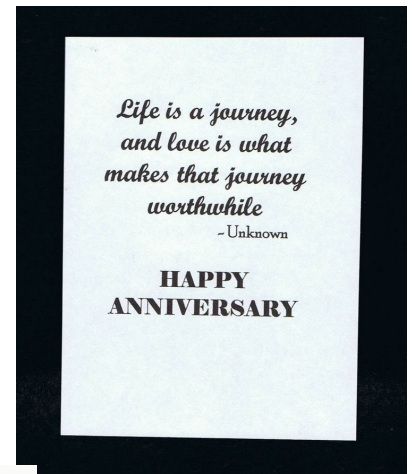

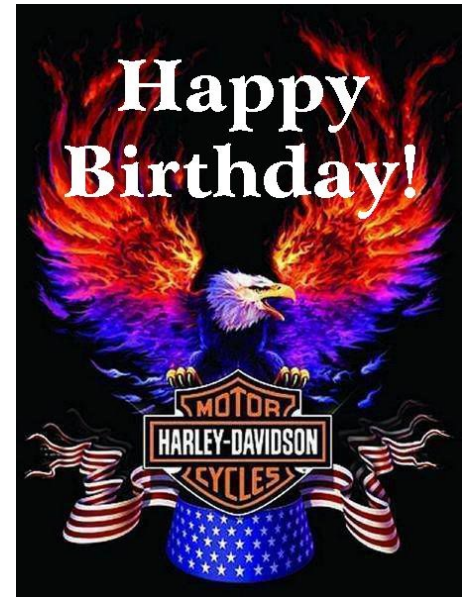
Hi Everyone!
